2) After careful examination of the matter the following partial amendments are issued with effect from 08/05/2020.

S.No	G.O.Rt.No.148, A&C (Agri.II) Dept., Dt:17.03.2020 - As mentioned in Para-C - (Claim reimbursement by the Government.)	To be read as
i.	The final list shall be consolidated village-wise and district-wise by convening a meeting of the District Level Bankers' Committee. After consolidating all such lists from the districts, it will be submitted to the SLBC which inturn will raise a claim to the Commissioner of Agriculture / Government and will be reimbursed to the Farmer through Account Payee Cheques.	<ol style="list-style-type: none">1. The Amounts to the Eligible Farmers who have outstanding Loan up to Rs.25,000/- will be credited in the First Phase in Online mode to the Loan Account of the Farmer instead of distribution of the A/c payee cheque.2. The JMLBC, DCC meetings, Gram Sabhas may not be conducted as the Meetings have huge gathering in view of Covid-19 restrictions. Instead 'NIC' shall scrutinize and ensure that the ceiling of Rs. 25000/- is not crossed per family using Aadhar Data. For the farmers who do not have Aadhar data at present the relief towards debt would be taken up after Aadhar Data is updated.
